Fire Chief:



NOW THEREFORE, be it RESOLVED by the Commissioners of Fire District No.4, in the Township of Woodbridge, County of Middlesex as follows:

The Fire District is hereby authorized to file a application with the Local Finance Board for the Lease Purchase Finance Agreement in the amount of \$ 835,000.00 for the purchase of a new Pierce 100' Mid Mount Aerial Platform Truck , and not to exceed the amount of \$1,360,000.00.
