The December 30<sup>th</sup>, 2024 meeting was opened by President Krejci, commissioners in attendance were, D. Polidura, R. Polidura, Reyes, and R. Pawol. The two accountants were not in attendance for this meeting. The attorney was not present or required to attend this board meeting, the pledge of allegiance was said followed by a moment of silence.

Minutes of the Previous Meeting:

We have had major issues with the HVAC system which is over 40 years old and we can not order replacement parts.

Trucks & Equipment:

Tower Ladder 424 is back from being repaired and is currently in service.

Finance & Budget:

Mr. Pawol, reported that the 2025 budget was adopted by resolution tonight, there were no members of the public to ask any question about the operating budget.

New Business:

Three (5) new resolutions were approved during this meeting: Resolution to Adopt the 2025 Budget.

Resolution to approve a temporary operating budget in the amount of \$183,405.00.

Resolution to transfer funds from budget line items with excesses to budget items with insufficient balances in the amount of \$23,830.00.

A motion was made by Edwin Reyes, to purchase (3) three new gas meters, and calibration gas not to exceed the amount of \$3,000. Seconded by R. Polidura, all were in favor.

A motion was made by Krejci for an emergency purchase to replace one of the HVAC units for the large meeting room due to we have no heat in half of the building at this time at a cost not to exceed the amount of \$17,500.00, seconded by R. Polidura, all were in favor.
