_____ No report this month.

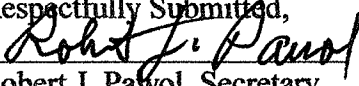

RESOLUTION 2025-14
Requirements Of Hiring Career Firefighters

WHEREAS, the Fire District wishes to establish the following requirements for new applicants;

To be hired as a Woodbridge Township Fire District No. 4, Career Firefighter, you must meet the following requirements:

- * Pass both the Civil Service test, and physical performance test.
- * Be a U.S. citizen at the time of appointment.
- * Be able to prove your identity & right to obtain legal employment in U.S.
- * Pass background check, medical & drug screening.
- * Be at least 21 years of age at the time of appointment.
- * Be able to understand and write in the English language.
- * Hold a valid NJ Drivers License for a minimum of 3 years.
- * Must be a resident of Woodbridge Township, New Jersey

Now, therefore these hiring requirements shall be put in place along with NJ CSC rules.
