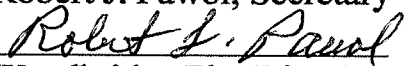

Two fire officers from Hopelawn Dist #8 presented a letter from there Board of Commissioners stating that starting on June 9th @ 6:00 AM that they will no longer respond into District #4, for any calls other than mutual aid help. Fire Department Captain Alex Salgado, was also at this meeting answering any questions that the two officers from Hopelawn that needed to be cleared up.

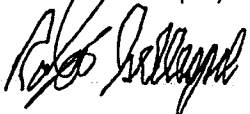
Re: Termination of Automatic Aid

Recently, Keasbey Fire Department entered into a shared service agreement with Woodbridge Fire District #1 to provide supplemental staffing for the career side. This was done to attempt to alleviate issues around manpower and experience. Due to the efforts put forth by the commissioners of Fire District #4, it is apparent that they no longer require the mutual aid services provided by the Hopelawn Engine Company #1.

Beginning Monday, June 9th at 0600 hours, calls in either district #4 or district #8 shall be dispatched as single company responses, respectively. This applies for all alarms 24 hours a day, 7 days a week. If Keasbey Fire Department or Hopelawn Engine Company request mutual aid for an alarm, then the pre-established mutual aid run cards shall be followed. This change in protocol does not negate any future requests for automatic aid to specific life hazard locations or alarm types.
