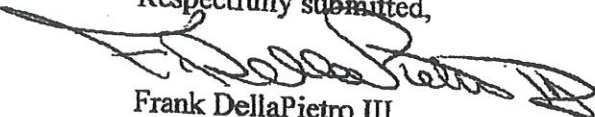
The Bureau issued 1 permit during the months of August 2015.
